In order to diversify and remain in liquid bond issues with a comfortable issue size, the Multiple Managers European Bond fund will invest in government bonds, which provide good quality returns, complemented by investment grade quality corporate bonds. In addition, the fund may (temporarily) hold cash.

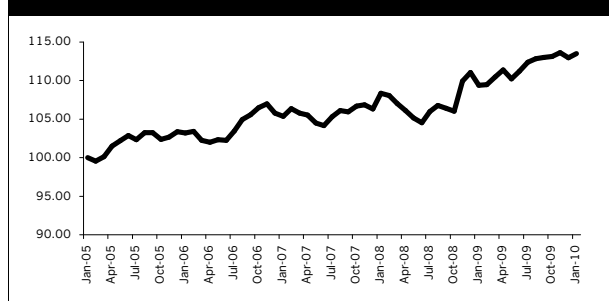
